**to qualify for USBCHA Open points**

Handler's meeting at **10:30 AM MST** (subject to change) at the Kjerstad Event Center at the Fairgrounds in Rapid City, SD. Course will be explained at the handler's meeting. **Preliminaries to start at 11 AM.**

-Entry fee is \$55/dog. For USBCHA sanctioning toward Open points add \$3.50 sanctioning fee per dog. Entries are limited to 3 dogs per handler and a total entry limit of 65 dogs. If additional dogs are remaining after entry limit is reached they will be added to a wait list. Enter dogs in the order you would like them to run. Entries and run order will be drawn on January 13, 2017. After January 13, refund will only be granted with a signed Veterinary certificate.

**-Optional USBCHA Sanctioning: If you would like your Preliminary run to qualify toward USBCHA Open points then you need to notate on entry and add \$3.50 sanctioning fee. IF you do NOT want your run to count toward USBCHA points it will not and you do not need to pay \$3.50 fee. Only dogs who pay \$3.50 sanctioning fee WITH ENTRY will count toward USBCHA Open points. Trial will otherwise run just as it has in years past.**

-The top 16 Preliminary dogs will compete in the Semi Final, with the top 10 returning for the Final. Any handler may qualify 3 dogs in the Semi Final and 2 dogs in the Final.

-At trial check-in you will receive a wristband for entry, along with one adult companion wristband and two children's wristbands if needed. Additional passes are available at the door for \$12 each.
